

AFL MEMBERSHIP GIVE-AWAY @ THE COVE HOTEL

Terms and Conditions

PROMOTIONAL PERIOD

1. The AFL Membership give-away @ The Cove Hotel (the **Promotion**) commences on Friday 25th August and concludes Saturday 23rd September, 2017 (the **Promotion Period**).
2. The major prize draw (if applicable) will take place on Saturday 23rd September at The Cove Hotel.

ELIGIBILITY

3. In order to participate in the Promotion patrons must not have been excluded (whether self or otherwise).
4. By entering or participating in the Promotion each eligible participant agrees to abide by these terms and conditions and the membership rules.
5. Employees, management and licensees of The Cove Hotel and their families are ineligible to enter the Promotion.

ENTRY REQUIREMENTS

DAILY KIOSK SWIPE

6. Pegasus Rewards Club members will receive one entry daily when they swipe their membership card at the member kiosk at The Cove Hotel. Once printed, the entry is to be placed in the official entry barrel located in venue.

ENTRY VIA IN VENUE CASH PURCHASES

7. Pegasus Rewards Club members will receive 1 official entry into the Promotion each time they make a cash purchase in any food and beverage outlet (of any value) at The Cove Hotel (maximum 2 per day)
8. Pegasus Rewards membership cards will need to be swiped to be eligible – it is the responsibility of the member to present their membership card at time of purchase.
9. All entries will be automatically printed the next time their Pegasus Reward card is swiped at the kiosk for placement into the barrel located at the venue.

MAJOR PRIZE DRAW EVENT

10. On Saturday 23rd September at approximately 6pm, venue staff will draw 1st, 2nd and 3rd prizes winners (in that order) from the entries placed in the barrel.
11. Should the winners not be present at the Venue for the major prize draw, The Cove Hotel venue staff will contact the winners via customer details provided in the Pegasus Rewards database.

THE PRIZE

12. The Major prize for the Promotion is 1 Silver AFL Membership for the AFL team of the winner's choice. The major prize has a value of approximately \$600.00 (including GST).
13. The second prize for the Promotion is 1 Bronze AFL Membership for the AFL team of the winner's choice. The second prize has a value of approximately \$250.00 (including GST).
14. The third prize for the Promotion are 2 Slabs of Carlton Draught. The value of the third prize is approximately \$100.00 (including GST).
